

## Donations and tax efficient giving to Gympanzees

**Gift Aid Declaration:**

As a registered charity all donations to Gympanzees can be tax efficient, significantly increasing the value of your gift at no extra cost to you. The table below gives examples – please speak to us for details.

Gift amount to a standard rate taxpayer	Cost to a 40% higher rate taxpayer*	Cost to a 45% higher rate taxpayer*	Gross value to Gympanzees with Gift Aid
£1,000	£750	£687.50	£1,250
£5,000	£3,750	£3,438	£6,250
£10,000	£7,500	£6,875	£12,500

<sup>\*</sup>If you pay tax at the higher or additional rate, you can claim the difference between the rate you pay and basic rate on your donation through your self-assessment tax return. Please keep a record of your donation.

<sup>\*</sup>You can claim Income Tax relief by deducting the value of your donation from your total taxable income for the tax year (6 April to 5 April) in which you made the gift or sale to charity. There is no CGT on an outright gift of shares to Gympanzees.
